- b) § 7 clauses 1 and 2 shall read as follows:
1. The share capital of the Company amounts to PLN 24,417,107.50 (say: twenty four million four hundred and seventeen thousand one hundred and seven zlotys 50/100).

2. The share capital is divided into 9,766,843 (say: nine million seven hundred and sixty six thousand eight hundred and forty three) shares paid up in cash, of the nominal value of PLN 2.50 (say: two zlotys fifty groszes) each.
 - c) In § 7 clause 4, points 9 and 10 are added as follows:
 - 9) 85,500 (say: eighty five thousand five hundred) K series shares;
 - 10) 31,191 (say: thirty one thousand one hundred and ninety one) L series shares.
 - d) § 14 clause 2 point 9 shall read as follows:
 - 9) selection of an audit firm to carry out the audit of financial statements of the Company and the Capital Group, as well as selection of an audit firm to attest sustainability reporting;
2. The resolution comes into force on the date of its passing, effective on the date of registration of the Company Articles of Association amendment in the National Court Register.

Justifications for the resolutions

Ref. Item 9 of the Agenda

Recommending to the Annual General Meeting the dividend payment in two tranches at the aforesaid dates, the Management Board of the Company considered the current and the expected financial standing of the Company.

Ref. Item 13 of the Agenda

1. Amendment to § 6 of the Articles of Association is to adjust the determination of the object of the Company's activities to the Regulation of the Council of Ministers of 18 December 2024 on the Polish Classification of Activities (PKD).
2. Amendment to § 7 of the Articles of Association is of editorial nature. It is necessary with regard to a change in the value of the Company share capital and the number of shares of the particular series, in relation to taking up shares by eligible persons within conditional share capital increase. When an increase in the Company share capital as a result of taking up shares by eligible persons is registered by the Court, it does not automatically update the value of the capital or the number of shares determined in the Company Articles of Association. The proposed amendment is to make the provisions of the Company Articles of Association compliant with the data entered in the National Court Register (KRS) with regard to the value of the share capital and the number of the issued shares.
3. Amendment to § 14.2.9 results from the necessity of assigning the Supervisory Board the competence to select an audit firm which will not only carry out the audit of the financial statements but also attest sustainability reporting, in compliance with Article 66.4 of the Act on Accounting.

Passing the other resolutions by the Annual General Meeting results from the duties set out in the binding laws and the internal regulations of the Company.
